

PART 1 Nature of the insurances

Rule 1	Nature of the insurances
1.1 1.1.1	General Application of Rules Subject to the <u>Articles of Association</u> , the <u>ITIC Articles</u> and as stated herein, these Rules govern <u>your</u> insurance by <u>the Club</u> and your corporate membership of <u>ITIC</u> .
1.1.2	Insurance Act 2015 ITIC is a mutual in which members (and insureds of ITIC) insure each other through ITIC or its wholly-owned subsidiary, the Club, against the liabilities and costs insured under the ITIC Rules and these Rules, respectively.
	The following provisions of Insurance Act 2015 ("the Act") are excluded by these Rules and the terms of any <u>Certificate of Entry</u> , including any endorsements thereto:
	Section 8 of the Act is excluded. As a result a breach of the duty of fair presentation may entitle <u>the</u> <u>Club</u> to avoid the policy. <u>You</u> r attention is drawn to <u>Rule 17.3</u> .
	Section 10 of the Act is excluded. As a result all warranties in these Rules must be strictly complied with and a failure to do so will discharge <u>the Club</u> from any liability irrespective of any subsequent remedy of that breach. In relation to the payment of premium <u>your</u> attention is drawn to <u>Rule 18.3</u> .
	Section 13 of the Act is excluded. As a result <u>the Club</u> shall be entitled to exercise its right to terminate the insurance, and corporate membership of <u>ITIC</u> , of the senior and all joint members in the event that a fraudulent claim is submitted. Your attention is drawn to <u>Rule 14.7</u> .
	Section 13A of the Act is excluded. As a result <u>member</u> s are not entitled to interest on their claims. <u>You</u> r attention is drawn to <u>Rule 14.9.3</u> .
1.2 1.2.1	The insurance and corporate membership of ITIC You are insured in accordance with these Rules and the terms and conditions in your Certificate of Entry.
	The Rules are subject to the <u>Articles of Association</u> and the <u>ITIC Articles</u> . Your insurance is only for Parts 2, 3 and 4 of these Rules as set out in your Certificate of Entry. Parts 5 to 11 of the Rules apply to all insurances.
	Your Certificate of Entry may contain additional terms or vary these Rules.
1.2.2	In the event of any conflict between the terms of the <u>Certificate of Entry</u> and these Rules, the <u>Certificate of Entry</u> prevails.
1.2.3	Headings, hyperlinks and notes are inserted for convenience only and do not affect the construction or interpretation of these Rules.
1.2.4	If <u>the Club</u> accepts an application for insurance from an insured who is not already a <u>corporate</u> <u>member</u> of <u>ITIC</u> , then such insured shall, as from the date of commencement of such insurance, be and become a <u>corporate member</u> of <u>ITIC</u> . A <u>member</u> shall cease to be a <u>corporate member</u> of <u>ITIC</u> if for any reason whatsoever it shall cease to have any risks insured with each of <u>ITIC</u> and <u>the Club</u> . For the avoidance of doubt, no contract of insurance or reinsurance with <u>the Club</u> shall entitle any person to be or become a <u>corporate member</u> of <u>the Club</u> .
1.3	Insured services and risks
1.3.1	Your insurance shall be confined to risks which are incurred in the normal course of providing the services specified in your Certificate of Entry.
	The normal course includes contracting or endeavouring to contract on terms and conditions usually applicable for the performance of those insured services.
1.3.2	<u>The Directors</u> shall have an absolute discretion to decide whether or not any risk was incurred in the normal course of providing such services.
	Any decision of <u>the Directors</u> as to whether any risk was so incurred shall be final and binding on <u>you</u> and <u>the Club</u> .

PART 1 Nature of the insurances

1.4	Indemnity insurance
<i>.</i>	Your insurance with the Club is on the basis of indemnity. The Club shall pay you only:
(a)	after you have discharged any liability whether by way of settlement or otherwise; and
(b)	<u>you</u> have discharged such liability by expenditure of money belonging to <u>you</u> unconditionally and not by way of loan or otherwise.
	However, <u>the Directors</u> may, in their absolute discretion, determine that <u>you</u> may recover monies under <u>you</u> r insurance with <u>the Club</u> although <u>you</u> have not paid the full amount of such liabilities and costs and may impose conditions upon such recovery as they consider appropriate.
1.5	Deductible
1.5.1	A claim payable under this insurance will be subject to the applicable deductible.
1.5.2	The applicable deductible will be:
(a)	the special deductible, if any, stated in <u>your Certificate of Entry</u> to be applicable to the relevant <u>insured service</u> or type of claim or cost; or, if none is stated,
(b)	the general deductible stated in <u>you</u> r <u>Certificate of Entry;</u> or, if none is stated,
(c)	US\$ 5,000.
1.5.3	Where there are two or more deductibles, which could apply to the same <u>occurrence</u> , the higher will apply. Only one deductible will be applied.
1.5.4	Only one deductible will apply to each and every <u>occurrence</u> , whether or not one or more joint <u>members</u> are included in <u>you</u> r insurance.
1.6	Limit of liability
1.6.1	A claim payable under this insurance will be subject to the applicable limit of liability less the applicable deductible.
1.6.2	The applicable limit of liability will be:
(a)	the special limit of liability, if any, stated in <u>your Certificate of Entry</u> to be applicable to a Rule, <u>insured</u> <u>service</u> or type of claim; or, if none is stated,
(b)	the general limit of liability stated in your Certificate of Entry; or, if none is stated,
(c)	US\$ 250,000.
1.6.3	If claims from the same <u>occurrence</u> are insured under more than one Rule, one limit will apply. The applicable limit will be determined in accordance with <u>Rule 1.6.2</u> .
1.6.4	Where there are two or more limits of liability that could apply to claims arising from the same occurrence:
(a)	claims which are subject to a special limit of liability will be subject to that special limit,
(b)	if two or more special limits could apply the higher will apply,
(c)	the total claims payable will not exceed the general limit of liability.
	However, if the special limit is higher than the general limit, the total claims payable will not exceed the higher limit. All claims will be subject to the general limit and only claims covered by the special limit will be paid in excess of the general limit.
1.6.5	Total claims payable under this insurance may be subject to an annual aggregate limit for each account year.
	The aggregate limit will be:
(a)	The special aggregate limit if any for that Rule, insured service or type of claim; or
(b)	The general aggregate limit of liability as stated in your Certificate of Entry.
	The total claims payable, whether subject to a special aggregate limit or the general aggregate limit will not exceed the general aggregate limit of liability.
	However, if the special limit is higher than the general limit, the total claims payable will not exceed the higher limit. All claims will be subject to the general limit and only claims covered by the special limit will be paid in excess of the general limit.
1.6.6	Subject to <u>Rule 1.6.4</u> and <u>1.6.5</u> , only one limit of liability will apply to each and every <u>occurrence</u> , whether or not one or more joint members are included in <u>you</u> r insurance.

PART 2 Professional indemnity insurance

	Your <u>Certificate of Entry</u> sets out the services and Rules for which <u>you</u> have insurance under this Part 2.
	Your attention is drawn to the qualifications and exclusions in <u>Rule 3</u> , in particular (but without limitation) <u>Rule 3.4</u> , and the general conditions and exclusions in <u>Rule 13</u> .
	Your obligations in respect of reporting claims are set out under <u>Rule 14</u> .
Rule 2	Professional indemnity insurance
2.1	Save as expressly stated below insurance under this <u>Rule 2.1</u> is for <u>you</u> r liability to third parties (including but not limited to any cost award to a third party) resulting from:
(a)	negligent performance of your insured services;
(b)	any fraudulent act of an <u>employee</u> other than a <u>controller</u> , committed in the performance of the <u>insured services</u> , excluding the loss of <u>cash</u> (see <u>Rule 13.23</u>), provided that it was intended by the fraud to benefit the <u>employee</u> and/or anyone else but <u>you</u> or any individuals, organisations or companies to which <u>you</u> are connected or affiliated;
(c)	 Defamation, excluding liability when you have agreed in advance to provide an interview or material for publication by any third party media.
	(ii) breach of confidentiality and/or infringement of intellectual property;
(d)	loss of or damage to documents or electronic data sustained while in <u>you</u> r custody or in the custody of any other person for who <u>you</u> are responsible but excluding claims arising from cyber attack (see <u>Rule 13.36</u>);
(e)	breach of warranty of authority;
(f)	any contract which <u>you</u> entered into on another person's behalf showing an intention to act as agent only;
(g)	responsibility for the liabilities of <u>you</u> r principal under any statute, law or regulation, excluding liability for <u>commercial debt</u> s;
(h)	claims by an <u>authority</u> in respect of:
	 storage costs, removal, disposal or marking of any cargo, equipment or <u>conveyance</u> which has been abandoned or involved in an accident;
	 (ii) costs of quarantine disinfection of any cargo, equipment or <u>conveyance</u> or any land, building or structure;
	(iii) costs of repairing damage done by a <u>conveyance</u> to <u>third party property;</u>
	(iv) payment under indemnities given in the normal course of business (see <u>Rule 1.3</u>);
	 (v) fines, penalties or customs duty imposed on <u>you</u> or <u>you</u>r <u>employee</u> or any person acting on <u>you</u>r behalf in respect of:
	(1) non-delivery, short-delivery or over-delivery of cargo or
	(2) smuggling, other than by a <u>controller</u> or;
	(3) breach of laws or regulations relating to:
	(aa) immigration;
	(bb) <u>pollution</u> by oil or other hazardous or noxious or polluting substances (see <u>Rule 13.15</u>); or
	(cc) export or import of any cargo, equipment or <u>conveyance</u> .
2.2	Damages The damages insured under this <u>Rule 2</u> include <u>you</u> r legal liability for:
(i)	financial losses of a third party;
(ii)	death or personal injury to any third party, including consequential losses arising therefrom;
(iii)	loss of or damage to third party property including consequential losses arising therefrom.

PART 2 Professional indemnity insurance

Rule 2.3	Associated costs
2.3.1	Costs insured
	In respect of a liability insured under <u>Rules 2.1</u> and <u>2.2 above</u> , if the sums claimed from <u>you</u> exceed, or are likely to exceed, the applicable deductible, <u>you</u> are insured for the following associated costs:
(a)	legal, surveying or expert fees and expenses;
(b)	costs of avoiding or minimising <u>you</u> r liability;
(c)	costs of replacing or restoring lost or damaged documents or electronic data;
(d)	costs of disposing of cargo;
(e)	costs of complying with an order by an <u>authority</u> .
2.3.2	Approval of costs
	You are insured for costs:
(a)	insofar as these have been approved by the managers; or
(b)	the Directors decide that they were properly incurred.
2.3.3	Overall limit and deductible
	The costs insured under <u>Rules 2.1</u> to <u>2.3</u> are included in the amount of the claim payable for the purposes of the applicable deductible and/or limit of liability. For the avoidance of doubt, any payments made by <u>the Club</u> pursuant to these <u>Rules 2.1</u> to <u>2.3</u> above are subject to the Policy's limit or limits of liability (less applicable deductible(s)) shown in <u>your Certificate of Entry</u> .
Rule 3	Exclusions and qualifications applicable to Rule 2
	Your attention is drawn to the general conditions and exclusions in Rule 13.
3.1	Claims made
	You are only insured if the risk arises directly from:
(a)	a claim first made or intimated to you and notified to the managers during the period of insurance; or
(b)	a claim made against or intimated to <u>you</u> after the <u>period of insurance</u> , arising out of circumstances notified to <u>the managers</u> during the <u>period of insurance</u> as circumstances which are likely to give rise to such a claim.
3.2	Negligence and liability under statute
	You are insured under <u>Rule 2.1(a)</u> to the extent that <u>you</u> have been negligent notwithstanding any statute, law or regulation imposing strict liability.
3.3	Customs bonds and guarantees
	You are not insured for any risk arising from your customs bond or guarantee being made available to a third party, unless directly related to your insured services.
3.4	Operational loss
	Insurance under <u>Rule 2</u> is for liabilities to third parties only except where expressly stated to the contrary. <u>You</u> are not insured for <u>you</u> r own losses.
3.5	Worldwide cover
	Unless stated in <u>your</u> <u>Certificate of Entry</u> , insurance under <u>Rule 2</u> is for liabilities incurred worldwide, subject to any specific limitations or exclusions imposed as a consequence of sanctions imposed by any national or international <u>authority</u> .

PART 3	Cargo and related liabilities
	Your <u>Certificate of Entry</u> sets out the services and Rules for which <u>you</u> have insurance under this Part 3.
	Your attention is drawn to the qualifications and exclusions in <u>Rule 8</u> and the general conditions and exclusions in <u>Rule 13</u> .
	Your obligations in respect of reporting claims are set out under <u>Rule 14</u> .
	Your insurance includes the associated costs resulting from your liability as referred to under Rule 8.
Rule 4	Liability insurance – physical loss of or damage to cargo
4.1	Insurance under this <u>Rule 4</u> is for <u>you</u> r liability for physical loss of or damage to cargo, including but not limited to consequential losses arising therefrom and any costs award to a third party.
4.2	Law and customer contracts
4.2.1	You are only insured under Rule 4 if your liability arises by virtue of any of the following:
(a)	any international transport convention or national transport law which imposes on <u>you</u> a compulsorily applicable regime of liability in respect of the carriage in question and cannot be avoided or limited by contract; or
(b)	any contract or standard trading conditions approved by <u>the managers</u> as set out in <u>your</u> <u>Certificate</u> <u>of Entry</u> .
4.2.2	If <u>you</u> seek to rely on a defence or limitation of liability provided for in any convention, law or contract referred to in this Rule, but a competent court or tribunal decides that <u>you</u> are not entitled to do so, <u>you</u> will be insured against the resulting liability, subject always to the terms and conditions of <u>you</u> r insurance.
4.3	Incorrect completion of bills of lading
	To the extent that <u>you</u> r liability is incurred or increased by an incorrect statement in, or omission from, <u>you</u> r bill of lading or other contract of carriage or handling documentation, <u>you</u> are not insured under <u>Rule 4</u> .
Rule 5	Errors and omissions insurance for transport operators
5.1	Insurance under this <u>Rule 5</u> is for <u>you</u> r liability (including but not limited to any costs award to a third party) for:
(a)	financial loss incurred by your customer arising from failure to perform your contractual obligations;
(b)	financial loss incurred by <u>you</u> r customer arising from any delay in performing <u>you</u> r contractual obligations;
(c)	financial loss arising from delivery of cargo contrary to <u>you</u> r contractual obligations which is incurred by <u>you</u> r customer or the person entitled under a bill of lading or other contract of carriage or handling documentation;
(d)	failure to perform <u>you</u> r contractual obligations – except for that financial loss arising from physical loss of or damage to cargo or property;
(e)	physical loss of or damage to cargo to the extent that <u>you</u> r liability is incurred or increased by an incorrect statement in, or omission from, any bill of lading or other contract of carriage or handling documentation.
5.2	Special limit of liability applicable to claims under Rule 5 Unless otherwise specifically provided for in these Rules a special limit of liability for claims under <u>Rule 5</u> will apply as stated in <u>your Certificate of Entry</u> . If, for any reason, it is not so stated, the total limit of liability under <u>Rule 5</u> each <u>account year</u> will be US\$ 50,000.

Rule 6	Third party liabilities
6.1	Insurance under this <u>Rule 6</u> is for <u>you</u> r liability (including but not limited to consequential losses and any costs award to a third party) resulting from:
(a)	physical loss / damage of third party property;
(b)	death, injury or illness of any third party;
(c)	to indemnify a third party for its liability for:
	(i) physical loss / damage of a <u>third party property;</u>
	(ii) death, injury or illness of any third party.
Rule 7	Liabilities for fines, penalties and duty
7.1	Insurance under this <u>Rule 7</u> is for <u>you</u> r liability (including but not limited to any costs award to a third party) arising from <u>you</u> r breach of any of the following regulations made by an <u>authority</u> relating to:
(a)	import or export of any cargo;
(b)	import or export of any <u>conveyance</u> or equipment;
(c)	immigration;
(d)	safety of working conditions;
(e)	pollution, but only where it arises from physical loss of or damage to cargo or equipment; resulting in:
	 (i) <u>you</u>r liability for fines or other penalties imposed by an <u>authority</u> on <u>you</u> or any person acting on <u>you</u>r behalf;
	 (ii) your liability for customs duty, sales or excise tax or similar fiscal charges which are imposed by an <u>authority</u> on you or any person acting on your behalf, and which would not have been payable but for the breach of any the regulations set out above;
	(iii) your liability arising from confiscation by an <u>authority</u> of any property belonging to a third party;
	(iv) your liability for financial losses incurred by a third party for the liabilities specified in (i)-(iii) above.
Rule 8	Associated costs
8.1	Costs
	In respect of any liability insured under <u>Rules 4</u> , <u>5</u> , <u>6</u> and <u>7</u> above if the sums claimed from <u>you</u> exceed or are likely to exceed the applicable deductible, <u>you</u> are insured for the following associated costs:
(a)	legal, surveying or expert fees and expenses;
(b)	costs of avoiding or minimising such liability;
(c)	costs of disposing of cargo following an accident to it;
(d)	costs of quarantine, fumigation or disinfection arising other than in the normal course of business;
(e)	costs of sending to the correct destination cargo that has been misdirected subject to such costs exceeding US\$ 1,000 (or equivalent in other currencies) calculated as in <u>Rule 8.4</u> below;
(f)	costs of meeting cargo's contribution in general average or salvage for which <u>you</u> are liable and which <u>you</u> are unable to recover from <u>you</u> r customer;
(g)	additional costs incurred solely by the total failure of any party to collect or remove cargo at the place of delivery; less
	(i) costs which you would have incurred in any event;
	(ii) proceeds from the sale of cargo;
	(iii) sums which <u>you</u> can recover from anyone else;

The limit of liability for costs in relation to Rules 8.1(g) and (h) will be restricted to US\$ 25,00 occurrence and in the aggregate each account year.8.2Approval of costs You are not insured for costs unless: (a)(a)these have been approved by the managers; or the Directors decide that they were properly incurred.8.3Disposal costs8.3.1You are not insured for the costs of disposing of damaged or worthless cargo unless such covery further recovery, from any other person.

8.4 Calculation of misdirection costs	
8.4.1 The costs incurred by <u>you</u> in sending cargo, that has been misdirected, to the correct destina are to be calculated as follows:	tion,
(a) the costs of transporting the cargo from the place at which <u>you</u> originally received it ("place of receipt") to the place which it was misdirected ("incorrect destination"), plus	
(b) the costs of transporting the cargo from the incorrect destination to its correct place of delivery, less	
(c) the freight and other charges due to <u>you</u> for the transport of that cargo.	
8.4.2 The cargo will not be transported by air from the incorrect destination to the correct place of delivery unless:	
(a) the transport from the place of receipt to the correct place of delivery was agreed to be by air,	or
(b) <u>the managers</u> so agree.	
8.5 General average and salvage guarantees	
8.5.1 In addition to the insurance under <u>Rule 8.1(f)</u> the <u>Club</u> will assist <u>you</u> to obtain the release of t cargo from any person who is entitled to lien it for general average or salvage contributions.	he
8.5.2 <u>The Club</u> will usually give such assistance either by arranging with the cargo underwriters the give, or by itself giving, a guarantee to the person entitled to such lien.	t they
8.5.3 Where <u>the Club</u> gives a guarantee, <u>you</u> must obtain a completed valuation form for the cargo prior to delivery of the cargo, obtain from the consignee or his cargo underwriters counter-see that is acceptable to <u>the Club</u> .	
8.6 Overall limit and deductible	
For the avoidance of doubt, any payments made by <u>the Club</u> pursuant to any of <u>Rules 4, 5, 6</u> , <u>8</u> are subject to the Policy's limit or limits of liability (less applicable deductible(s)) shown in <u>y</u> <u>Certificate of Entry</u> .	

Rule 9	Exclusions and qualifications applicable to Part 3
9.1	Claims made or claims occurring
	Your <u>Certificate of Entry</u> will specify the basis of <u>your</u> cover under <u>Rules 4, 5, 6</u> and <u>7</u> . If not so specified <u>you</u> are only insured if the risk arises directly from:
(a)	a claim first made or intimated to <u>you</u> and notified to <u>the managers</u> during the <u>period of insurance;</u> or
(b)	a claim made against or intimated to <u>you</u> after the <u>period of insurance</u> , arising out of circumstances notified to <u>the managers</u> during the <u>period of insurance</u> as circumstances which might give rise to such a claim.
9.2	Declared value and incorrect documentation
	You are not insured to the extent that your liability is incurred or increased by:
(a)	a declaration of value; or
(b)	package/unit enumeration in <u>you</u> r subcontractor's bill of lading, other contract of carriage or handling documentation which fails to correspond with the enumeration in <u>you</u> r equivalent document.
9.3	Valuable cargoes

	thoroughbred horses
	 computers/electronic devices and components of these
	Any combination of the above cargoes consolidated in the same carrying equipment or stored in one warehouse or depot will be subject to one special limit of liability.
9.4	Personal effects
	You are only insured for your liability in respect of personal effects if:
(a)	you could not, with the exercise of reasonable care, have known the consignment consisted of personal effects; or
(b)	<u>you</u> r customer is a <u>transport operator;</u> or
(c)	you specifically recommend in writing the purchase of cargo insurance.
9.5	Delay and operational loss You are not insured:
(a)	to the extent that <u>you</u> r liability for delay is increased by special instructions by <u>you</u> r customer; or

(c)	loss or damage to <u>you</u> r carrying or <u>handling equipment</u> .
9.9	Limit of liability

	(viii) any other provider of goods and services not directly related to <u>you</u> r performance of the <u>insured services</u> .
(b)	costs incurred in relation to any actual or alleged violation of any penal statute or regulation;
(c)	costs incurred in relation to any dispute with <u>you</u> r customer or principal as to the reconciliation of accounts on termination of <u>you</u> r services or <u>you</u> r customer or principal becoming insolvent;
(d)	costs incurred in relation to any claim by <u>you</u> or against <u>you</u> for defamation.
10.6	Property
	You are only insured for costs incurred in relation to any claim for loss of, damage to, or loss in connection with property owned by you or in your possession if you satisfy the Directors that you have taken reasonable steps to protect your interest in such property by insurance and that such costs are not recoverable under such insurance.
10.7	Costs of recovering monies advanced or remuneration for services rendered You are only insured for costs incurred in relation to claims for monies advanced by you, remuneration for services rendered by you, or financial loss arising out of the rendering of such services if you satisfy the Directors that:
(a)	<u>you</u> took reasonable steps to establish that the financial standing and business reputation of <u>you</u> r customer were satisfactory before <u>you</u> agreed to render any services; and
(b)	the extent of any credit given by you to your customer was reasonable; and

10.8	Contractual claims You are only insured for costs incurred in relation to any claim in contract, other than a claim referred to in <u>Rule 10.7</u> , if <u>you</u> satisfy <u>the Directors</u> that it was prudent and reasonable to enter into such a contract.
10.9	Weak claims and defences If, in the opinion of <u>the managers</u> , the claim being pursued by <u>you</u> is likely to fail or the claim being defended by <u>you</u> is likely to succeed, or the claim cannot be pursued or defended without the expenditure of costs that are disproportionate to the amount of such claim or the prospects of success, or any such claim is capable of being and ought to be settled, <u>the Club</u> may by notice to you terminate your insurance under <u>Rule 10</u> in respect of that claim, provided always that <u>your</u> rights in respect of costs incurred before such termination will not be prejudiced.
10.10	Average In the event that any dispute or debt to be collected includes elements which were not incurred in the normal course of performing the <u>insured services</u> or which are specifically excluded under this Rule, <u>the managers</u> may, at their sole discretion, agree to assist with the uninsured portion of the claim, subject to the costs being apportioned accordingly between <u>you</u> and <u>the Club</u> .
10.11	Approval of settlements You shall not settle or compromise any claim or proceedings without the prior approval of the managers, or without complying with the managers' requirements regarding the recovery of any costs or expenses insured by the Club. In the event you settle or compromise without such approval or without complying with any such requirement, the Club may by notice to you terminate your insurance under Rule 10 in respect of that claim and you shall become liable to repay to the Club all of the costs and expenses paid or reimbursed by the Club or such proportion of those costs and expenses as the Directors in their discretion shall determine.
10.12	You are not insured under this Rule for costs in relation to a claim that is covered under any other Rule or would be but for the application of a limit of liability, deductible, exclusion or other provision of your cover.
Rule 11	Discretionary insurance <u>The Directors</u> , may, at their discretion, additionally provide insurance against all or part of any liability <u>you</u> incur which is not otherwise insured under these Rules, but which, having regard to the overall purpose of the insurance, <u>The Directors</u> decide it is appropriate to cover. 13.3	Damage by vehicles
	You are not insured for any loss or damage directly or indirectly caused by the operation of any <u>ship</u> , <u>aircraft</u> , train, road or other vehicles, which is owned <u>charter</u> ed or leased by <u>you</u> or for <u>you</u> r use.
13.4	Employers' liability
	You are not insured for any risk arising directly or indirectly from:
(a)	the breach of any obligation owed by you as an employer or prospective employer;
(b)	the death, bodily injury or illness of any person employed, deemed to be employed or seconded to you or any sub-agent or subcontractor.
13.5	Products liability and defective workmanship
13.5.1	You are not insured for any risk arising directly or indirectly from defects in goods or products sold, supplied or distributed by <u>you</u> or on <u>you</u> r behalf unless the defects directly arise from <u>you</u> r <u>insured</u> <u>services</u> .
13.5.2	You are not insured for any risk arising from the manufacture, construction, alteration, repair, servicing, installation, maintenance or treating of any goods by you or on your behalf even though these activities might be performed in conjunction with the services specified in your Certificate of Entry as being insured services.
13.6	Design liability
	You are not insured if, at the point in time the insured service was carried out, the liability arose from research and development technologies and/or insufficiently tested new procedures or materials, unless specifically stated in your Certificate of Entry.
13.7	Senior and joint members
	You are not insured for any risk arising directly or indirectly from any claim by the <u>senior member</u> against any other joint member or by a joint member against the senior or another joint member.
13.8	Associated, parent or subsidiary companies
	You are not insured for any claim made against <u>you</u> by any associated, parent or subsidiary company or by any person or entity having a financial or executive interest in <u>you</u> r operation.
13.9	Double insurance
	If <u>you</u> are insured by <u>the Club</u> and another insurer for the same risk, <u>you</u> r insurance with <u>the Club</u> will exclude any claim if, and to the extent that, it is, or would be, recoverable from such other insurer.

Such certificates and other evidences of insurances will not be binding on us or provide proof of insurance cover in respect of any such transaction, shipment or claim.

	If you fail to notify the claim in accordance with Rule 14, the Directors may in their discretion:
(a)	accept the claim; or
(b)	reject the claim or reduce the sum which might otherwise be recovered by you from the Club; or
(c)	accept the claim, but subject to terms and conditions which would have applied had the claim been notified to <u>the Club</u> in accordance with <u>Rule 14.1</u> .
14.3	Mitigation of loss
	When circumstances arise which give rise or are likely to give rise to a claim, <u>you</u> shall take all reasonable measures to avoid or minimise any liability, loss, costs, damages or expenses in respect of the claim.
14.4	Information and cooperation
	You will cooperate at your own expense in the handling of the claim. You must promptly give the managers any information, accounts, or documents relevant to any claim and assist in the availability of any property for survey or inspection of or of any witnesses for interview. Information, accounts or documents must be provided to the managers in good order, properly explained and in a form appropriate for the efficient conduct of such a claim. You will make yourself and your employees available for any hearings (arbitration or litigation) or mediation as requested by the Club.
14.5	Members not to admit liability or settle claims
14.5.1	You shall not admit liability, or in any way compromise the claim (including costs or expenses insured by <u>the Club</u>) without the prior <u>written</u> consent of <u>the managers</u> and <u>you</u> shall undertake that none of <u>you</u> r <u>employees</u> or former <u>employees</u> admits any such liability.
14.5.2	You shall not pay or settle any claim without the prior <u>written</u> consent of <u>the managers</u> and <u>you</u> shall undertake that none of <u>you</u> r <u>employees</u> or former <u>employees</u> pay or settle any such claim.
14.6	Salvage and residual value
	The amount of any claim will be reduced by:
(a)	the proceeds of any salvage that you receive or to which you are entitled;
(b)	your interest in the residual value (if any) of the subject matter of the claim.
14.7	Fraudulent claims
	If <u>you</u> make any claim against <u>the Club</u> knowing the same to be false or fraudulent the insurance will be void as at the date of the fraudulent act. <u>The Club</u> 's rights against <u>you</u> and <u>you</u> r obligations to <u>the Club</u> remain unchanged.

PART 6 Claims

14.8	Conduct of claims
14.8.1	Managers' power to conduct proceedings
	<u>The managers</u> have the right to control or direct the conduct of any claim, in respect of which <u>you</u> are or may be insured and to require <u>you</u> to settle, compromise or otherwise dispose of such claim in such manner and upon such terms as <u>the managers</u> see fit.
14.8.2	Appointment of advisors
14.8.2.1	<u>The managers</u> may at any time appoint on <u>you</u> r behalf, on such terms as <u>the managers</u> think fit, experts, lawyers, surveyors and/or other persons (advisors) with a view to advising upon investigating or dealing with any matter which may result in a liability, in respect of which <u>you</u> are or may be insured, including taking or defending legal or other proceedings in connection therewith, notwithstanding that <u>you</u> may have already have appointed <u>you</u> r own advisors. <u>The managers</u> may also at any time discontinue such appointment if they think fit.
14.8.2.2	All advisors appointed by <u>the managers</u> on <u>you</u> r behalf, or appointed by <u>you</u> with the prior consent of <u>the managers</u> , shall at all times be and be deemed to be appointed on the terms:
(a)	that they are authorised to report and give advice to and to take instructions from the managers;
(b)	that any advice given by them is that of an independent contractor appointed by <u>you</u> and shall in no way bind <u>the Club</u> .
14.9	Payment of claims
14.9.1	No claim shall be paid without the approval of the Directors or the managers.
14.9.2	$\frac{\text{The Directors}}{\text{Club}} \text{ have the power in their discretion to reject a claim or reduce the sum payable by } \frac{\text{the}}{\text{Club}} \text{ in respect thereof, if:}$
(a)	in the opinion of <u>the Directors you</u> have not taken such steps before, at the time of, or after <u>you</u> had knowledge of the circumstances likely to give rise to the claim, to protect <u>you</u> r interests as <u>you</u> should have done or would have as a prudent uninsured;
(b)	you have settled a claim against you or have admitted any liability without the prior consent in writing of the managers;
(c)	you have failed to comply with a recommendation or direction in respect of the handling of the claim made by <u>the Directors</u> or <u>the managers</u> .
14.9.3	Interest
	You are not entitled to be paid interest on your claim against the Club.
14.9.4	Currency
	If claims are paid in currencies other than the currency in which <u>your</u> <u>Certificate of Entry</u> is underwritten, the exchange rates for determining the applicable limits of liabilities and/or applicable deductibles will be applied as at the date of payment.
14.9.5	Senior and joint members
14.9.5.1	Payment by <u>the Club</u> of any claim (including costs and expenses) to the <u>senior member</u> or any other <u>joint member</u> s shall be deemed to be the receipt by the <u>senior member</u> and all <u>joint member</u> s jointly and severally and shall fully discharge the obligations of <u>the Club</u> in respect of such payment.
14.9.5.2	Where any claim payment (including costs and expenses) has to be repaid to <u>the Club</u> or any deductible is owed to <u>the Club</u> and two or more <u>firms</u> or individuals are the subject of the joint entry, the <u>senior member</u> and each joint <u>member</u> shall be jointly and severally liable to <u>the Club</u> in respect of such sums due.

PART 7	Entry, joint membership, period of insurance, and disclosure obligations
Rule 15	Entry and joint membership
15.1	Applications If you wish to apply for insurance, you have to provide information as may be required by <u>the</u> <u>managers</u> and all other information necessary to make a fair presentation of the risk. For the material information to be within the <u>member</u> 's or joint <u>member</u> 's knowledge the provisions of the Insurance Act 2015 apply.
15.2	Certificate of Entry
	Upon acceptance of <u>you</u> r application for the insurance, <u>you</u> become a <u>member</u> of <u>the Club</u> and <u>the</u> <u>managers</u> will issue <u>you</u> with a <u>Certificate of Entry</u> recording the agreed terms.
15.3	Joint members – disclosure
	Failure by the <u>senior member</u> or any other joint <u>member</u> to disclose material information within their knowledge shall be deemed to be failure of the <u>senior member</u> and all the joint <u>members</u> .
15.4	Variation of cover
	If at any time <u>the managers</u> agree to vary the terms and conditions upon which <u>you</u> are insured, <u>the managers</u> , as soon as reasonably practicable thereafter, shall issue an endorsement to the <u>Certificate of Entry</u> stating the nature of such variation and the date from which such variation is to be effective.
15.5	Becoming a member
	Insurance can be as a single <u>member</u> where that <u>member</u> is entered as a <u>senior member</u> or jointly, naming the <u>senior member</u> together with the joint member(s).
15.6	Liability for premium
	Where two or more <u>firms</u> or individuals are the subject of the joint entry the <u>senior member</u> and each joint <u>member</u> shall be jointly and severally liable to pay all premium due to <u>the Club</u> in respect of such entry.
15.7	Joint members – conduct
	Conduct of the <u>senior member</u> or any other joint <u>member</u> which would have entitled <u>the Club</u> to decline to indemnify them shall be deemed to be the conduct of the <u>senior member</u> and all the joint members.
15.8	Joint members – termination of insurance
	Where two or more <u>firms</u> are the subject of a joint entry, termination of the insurance of the <u>senior</u> <u>member</u> or of any other joint <u>member</u> will automatically terminate the insurance of the <u>senior</u> <u>member</u> and all of the joint <u>members</u> , unless otherwise agreed by <u>the managers</u> .
15.9	Communications
15.9.1	All communication from the Club will be sent to the senior member and shall be deemed to be made to and within the knowledge of all the other joint members.
15.9.2	All communication between the <u>senior member</u> and <u>the Club</u> or <u>the managers</u> shall be deemed to have been made or given with the full approval and authority of all the joint members.

PART 7	Entry, joint membership, period of insurance, and disclosure obligations			
Rule 16	Period of insurance and renewal			
16.1	Period of insurance			
	Your period of insurance is as stated in your Certificate of Entry or subsequent endorsements.			
	The Club's underwriting is based on annual <u>Club policy years</u> . Your period of insurance may fall into one or more <u>Club policy years</u> .			
16.2	Where your period of insurance is for two or more policy years or the managers agree that your period of insurance commences part way through a <u>Club policy year</u> and continuing into the next <u>Club policy year</u> , you are insured subject to the <u>Rules</u> applicable during the first <u>Club policy year</u> provided that the <u>Club</u> may on giving you no less than 28 days' notice in writing make your insurance cover subject to the <u>Rules</u> applicable to the second or any subsequent <u>Club policy year</u> .			
16.3	Renewal			
16.3.1	Prior to the expiry of <u>your period of insurance the managers</u> may request information concerning <u>you</u> r business or offer renewal terms on the basis that there have been no material changes since the commencement of the last <u>period of insurance</u> .			
16.3.2	After receiving such information or confirmation that there have been no material changes <u>the</u> <u>managers</u> may offer terms to renew <u>you</u> r insurance.			
16.3.3	If the offer is on the basis that there have been no material changes <u>you</u> r agreement to such terms is expressly on that basis.			
16.3.4	The managers are under no obligation to provide reasons for their renewal terms offered.			
16.3.5	If no agreement on the renewal of <u>you</u> r insurance has been reached prior to the expiry of <u>you</u> r <u>period of insurance</u> , <u>you</u> r insurance will cease with effect from the expiry of that <u>period of insurance</u> .			
16.3.6	However, <u>the managers</u> may agree <u>in writing</u> to continue to hold <u>you</u> covered on expiring terms as stated in <u>your Certificate of Entry</u> for such period and subject to the payment of any amounts, which <u>the managers</u> may in their discretion require.			
16.3.7	Once renewal terms have been agreed <u>the managers</u> will issue <u>you</u> with a new <u>Certificate of Entry</u> reflecting the agreed terms which will replace the terms on which <u>you</u> were held covered.			
16.4	Non-renewal			
	<u>The Directors</u> may decide in their discretion not to offer renewal terms. <u>The managers</u> will endeavour to give <u>you written</u> notice of 21 days of their intention not to renew <u>you</u> r insurance.			
	The Directors are under no obligation to give any reasons for the decision not to renew your insurance.			
16.5	Break clause			
	If the period of insurance stated in <u>your Certificate of Entry</u> is for a period of longer than 12 months, then <u>the managers</u> shall have the right to review the policy terms and premium six weeks prior to the end of every <u>account year</u> . If amended terms and/or premium are agreed, these are to apply from the start of the next <u>account year</u> unless otherwise agreed. If any new terms and/or premium cannot be agreed then <u>you</u> and <u>the Club</u> have the right to terminate the policy with effect from the end of the active current <u>account year</u> upon the giving of notice in writing no later than 2 weeks prior to the expiry of the active current <u>account year</u> . In the absence of either party serving a notice of termination, then the new terms will apply with effect from the start of the new <u>account year</u> .			
16.6	This <u>Rule 16</u> is without prejudice to the provisions of <u>Rules 17</u> , <u>18</u> and <u>19</u> .			

PART 7	Entry, joint membership, period of insurance, and disclosure obligations			
Rule 17	Disclosure obligations			
17.1	Disclosure of material information You are under a duty to ensure that any information given to the Club leading to the issue of any <u>Certificate of Entry</u> is in all material respects complete and accurate and represents a fair presentation of the risk.			
17.2	Continuing obligations			
	During your period of insurance, you have a continuing duty to report any material circumstances or material changes in the risk. This includes but is not limited to:			
(a)	any material change in, or addition to, the information given to the Club pursuant to Rule 17.1;			
(b)	any merger, amalgamation or division affecting the insured firm or firms or the insured services;			
(c)	the opening or closing of any office premises of the insured <u>firm</u> or <u>firm</u> s from which the <u>insured</u> <u>services</u> have been or will be carried on;			
(d)	the occurrence of any of the matters listed in Rule 18.1;			
(e)	any information which could influence the Club's assessment of the risk.			
17.3	Effect of non-disclosure of material information			
17.3.1	In the event of a breach of <u>you</u> r disclosure obligations, without prejudice to the provisions of <u>Rules</u> <u>18</u> and <u>19</u> , <u>the Directors</u> may:			
(a)	Terminate your insurance and treat it as void and unenforceable from the commencement of the <u>period of insurance</u> . This would include (but is not limited to) circumstances where the failure to disclose was deliberate, reckless or otherwise so serious as to make such termination appropriate. In such incidences <u>the Club</u> has the right to reject all claims.			
(b)	Give notice to you terminating the insurance with effect from the specified date. This would include (but is not limited to) circumstances where the breach was of the continuing obligations under <u>Rule 17.2</u> .			
(c)	Reject or reduce the amount payable in respect of any individual claim. This would include (but is not limited to) circumstances where the breach was relevant to that specific claim, but not other claims.			
(d)	Impose other conditions on the continuation of <u>you</u> r insurance. This would include (but not be limited to) circumstances where the breach would have had a material effect on the terms on which the risk was underwritten or the premium charged.			
17.3.2	In the event of any of the above, the Club is under no obligation to return any premium.			
17.3.3	The Directors are under no obligation to provide any reasons for their decisions.			

PART 8 Cesser or suspension of insurance by the Club and of corporate membership of ITIC

Rule 18	Cesser or suspension of insurance by the Club and of corporate membership of ITIC	
18.1	Automatic cesser of insurance	
	The following events will result in the automatic cesser of <u>you</u> r insurance by <u>the Club</u> and of your corporate membership of <u>ITIC</u> :	
(a)	the commencement of proceedings under any bankruptcy or insolvency law applicable to <u>you,</u> including but not limited to:	
	(i) entering into an arrangement with creditors;	
	(ii) seeking protection against creditors;	
	(iii) the appointment of any liquidator, administrator, receiver, administrative receiver or insolvency practitioner of any kind in relation to <u>you</u> or <u>you</u> r assets.	
(b)	you cease the performance of all insured services;	
(c)	if being a natural person you die or are declared mentally unsound;	
(d)	if being a legal person <u>you</u> are dissolved;	
(e)	you or any person (legal or natural) with an ownership interest of 25% or more become subject to any sanction, prohibition or restriction under United Nations resolutions or the trade or economic sanctions, laws or regulations of the European Union, United Kingdom or United States of Americ	
18.2	Cesser or suspension of insurance at option of the Club	
18.2.1	If <u>the Club</u> is notified under <u>Rule 17.2</u> or becomes aware of any matter which <u>the Directors</u> consider in their discretion, alters the nature of the risk insured, <u>the Directors</u> may give <u>you</u> 14 days' notice <u>in</u> <u>writing</u> :	
(a)	of such terms and conditions (including if appropriate such revised premium) that are required to continue to insure <u>you</u> for the remainder of the <u>period of insurance</u> . This includes (but is not limited to) circumstances in which <u>you</u> advise the addition of new offices or changes to <u>your insured</u> services; or	
(b)	that <u>you</u> r insurance will be terminated from such date (in which case the provisions of <u>Rule 1.2.4</u> shall apply). This includes (but is not limited to) circumstances where <u>the Directors</u> consider that the risk is fundamentally different from that originally disclosed.	
18.2.2	If the Club is notified or becomes aware of:	
(a)	any circumstance under <u>Rule 13.32;</u> or	
(b)	any circumstance regarding sanctions, war, invasions, conflicts or issues which <u>the Directors</u> may consider in their discretion, directly or indirectly alters the nature of the risk insured or that the risk has become fundamentally different due to external factors despite no material change to any <u>member</u> 's circumstances,	
	the Directors may in writing (where it is possible to do so) terminate the insurance with immediate effect (in which case the provisions of <u>Rule 1.2.4</u> shall apply) or suspend the insurance.	
18.3 18.3.1	Cesser of insurance for failure to pay Where <u>you</u> fail to pay any amount due to <u>the Club</u> , <u>the managers</u> may give notice <u>in writing</u> requiring payment by the date specified in such notice, this date not being less than fourteen days from the date of the notice.	
18.3.2	Any failure to comply with this notice may result in <u>you</u> r insurance being cancelled as of the commencement date without further notice (in which case the provisions of <u>Rule 1.2.4</u> shall apply at the time of such cancellation). Such cancellation is without prejudice to any other remedies available to <u>the Club</u> by virtue of these Rules or by law.	
18.3.3	The Club is not liable for any claims notified to the Club within a period of insurance for which the advance and or supplementary premium is due and has not been received in full.	

PART 8	Cesser or suspension of insurance by the Club and of corporate membership of ITIC		
18.4	Cesser or suspension for reputational risk <u>The Directors</u> may in their discretion, immediately suspend or terminate the insurance, upon <u>written</u> notice, where <u>the Club</u> is notified or becomes aware of any circumstance which <u>the Directors</u> believe puts <u>the Club</u> at risk of reputational damage.		
18.5	Consequences of cesser or suspension		
18.5.1	If the cesser of insurance occurs for any of the reasons set out above other than cesser for failure to pay, cesser under <u>18.1(e)</u> , or cesser under <u>18.2.2</u> , <u>the Club</u> remains liable for all claims under these Rules arising out of any claim or circumstances validly notified under these Rules before the date of cesser.		
18.5.2	Under all circumstances, <u>you</u> are and remain liable for all amounts due to <u>the Club</u> in respect of the <u>period of insurance</u> in which the date of cessation occurs, pro rata for the period up to the date of cessation, and in respect of any previous <u>period of insurance</u> including any supplementary premium levied.		
18.5.3	If your policy is suspended there is no insurance cover available to you at all in respect of the suspended policy until such time that the policy is reinstated. However, you will remain a corporate member of ITIC during the period of suspension of the policy. In order to be reinstated the Club must expressly reinstate the policy in writing. During the period of suspension the Club has the right to terminate the policy immediately by giving written notice. The period of suspension along with the policy will automatically terminate on the date the policy was due to expire if it has not been terminated or reinstated by such date. If the policy is reinstated, the period of insurance will not be extended by the duration of any suspension period.		
18.6	Director's discretion to cover claims		

<u>The Directors</u> may, in their absolute discretion, accept any claim for which <u>the Club</u> is under no liability under this <u>Rule 18</u> whether the notification giving rise to such claim was made before or after the cesser of insurance.

PART 9	Funds of the club			
Rule 19	Contribution by way of premium			
19.1	Insurance all of same class All <u>member</u> s pay into a common fund regardless of any difference in the services or insured interest as between <u>you</u> and another <u>member</u> or between one group of <u>member</u> s and another.			
19.2	Premium			
19.2.1	ITIC is a mutual in which members (and insureds of ITIC) insure each other through ITIC or its wholly-owned subsidiary, the Club, against liabilities and costs insured under the ITIC Rules and these Rules, respectively, which any of them may become liable to pay.			
19.2.2	The <u>member</u> s contribute, in accordance with <u>Rule 20</u> by means of advance premium and, if required, through supplementary premium, in order to meet:			
(a)	the liabilities, expenses and other outgoings of <u>the Club</u> (whether incurred, accrued or anticipated), which in the opinion of <u>the Directors</u> necessarily and properly fall upon <u>the Club</u> in respect of such <u>Club policy year</u> ;			
(b)	such transfer to reserves or provisions as <u>the Directors</u> may deem is expedient to make, including transfers to reserves and provisions in respect of any deficiency which has occurred or which may be thought likely to occur in respect of any <u>closed Club policy year</u> as <u>the Directors</u> think fit;			
(c)	such sums as <u>the Club</u> may by any legislation or regulation be required to set aside in order to establish and/or maintain an adequate solvency margin and/or fund in respect of any <u>Club policy year</u> .			
Rule 20	Premium			
20.1	Advance premium			
20.1.1	Your advance premium is stated in your <u>Certificate of Entry</u> . The total amount of all advance premium levied on all <u>members</u> is calculated with the intention that the funds will be adequate to meet the foreseeable liabilities, expenses and outgoings of <u>the Club</u> for that <u>Club policy year</u> .			
20.1.2	Where an advance premium is levied in respect of a <u>period of insurance</u> which covers more than one <u>Club policy year</u> , the advance premium is treated as being payable in relation to the earlier of those <u>Club policy year</u> s.			
20.1.3	If the <u>period of insurance</u> is for more than one <u>account year</u> the advance premium for the first <u>account year</u> will be treated as being payable in respect of the <u>Club policy year</u> current at the commencement of that first <u>account year</u> . Premium for further <u>account year</u> s will be treated as being payable in respect of the <u>Club policy year</u> in force as at the date of the commencement of that <u>account year</u> .			
20.2	Supplementary premium At any time prior to closing a <u>Club policy year</u> , the <u>Directors</u> may decide to require in respect of that year supplementary premium of such amount(s) as they may determine, if they consider that the advance premium paid in respect of such <u>Club policy year</u> are (notwithstanding the original intention) insufficient to meet the liabilities, expenses and outgoings of <u>the Club</u> for such <u>Club</u> <u>policy year</u> . The supplementary premium will be calculated pro rata to all advance premium levied for such <u>Club policy year</u> .			
20.3	Premium payable as Directors determine All or any part of any premium is payable at such rates, in such instalments, in such currencies and on such dates as <u>the Directors</u> may specify.			

PART 9 Funds of the club

20.4	Notification			
	As soon as reasonably practical after the premium has been set the managers will notify you:			
(a)	of the amount of such premium; and			
(b)	of the date the premium is payable; and			
(c)	currency in which the premium is payable.			
20.5	No set-off			
	You shall not be entitled to set-off the whole or any part of any claim on the Club against the premiums or other sums of whatsoever nature due to the Club nor shall you be entitled to withhold or delay payment of any such premiums or other sums.			
20.6	Interest on late payment			
	Without prejudice to the rights and remedies of <u>the Club</u> under any of these Rules or otherwise, if any premium or instalment or part thereof or any other sum of whatsoever nature due from <u>you</u> is not paid on or before the date specified for payment thereof <u>the Directors</u> may order <u>you</u> to pay interest on the amount not so paid, from and including the date so specified down to the date of payment, at such rate as <u>the Directors</u> may from time to time determine.			
20.7	Non-payment			
	If <u>the Directors</u> decide that any amount due to <u>the Club</u> cannot be obtained, <u>the Club</u> may levy supplementary premiums in accordance with this Rule or the reserves may be applied in accordance with <u>Rule 21.5</u> in order to rectify any deficiency of <u>the Club</u> 's funds.			
20.8	Forecasts of premiums			
	Any forecast given is indicative only and is without prejudice to the right of <u>the Directors</u> to levy supplementary premiums for that <u>Club policy year</u> at a higher or lower level than that forecast, or not to levy such premiums at all.			
	The Club, its Directors, managers and their servants and agents do not have any liability whatsoever in respect of any inaccuracy of any premium forecast.			
20.9	Fixed premium			
	If <u>the managers</u> so agree, and it is noted in <u>your Certificate of Entry</u> , <u>you</u> r insurance may be provided for a <u>fixed premium</u> , in which case the provisions of <u>Rule 20.2</u> do not apply.			
20.10	Recovery of premium			
	All monies due and payable by <u>you</u> to <u>the Club</u> may be recovered by action commenced on the instructions of <u>the managers</u> in the name of <u>the Club</u> .			

PART 9 Funds of the club

Rule 21	Closing of policy years			
21.1	The Directors can declare a <u>Club policy year</u> to be closed, as of any date after the end of that <u>Club</u> policy year.			
21.2	After a <u>Club policy year</u> has been closed, no further supplementary premiums can be levied in respect of that <u>Club policy year</u> .			
21.3	<u>The Directors</u> may declare a <u>Club policy year</u> is closed, although there may be claims or expenses which have not been established as at the closing date.			
21.4	Disposal of excess funds			
	If it appears to <u>the Directors</u> that the entire Club funds in respect of a <u>Club policy year</u> are unlikely to be required to meet all the liabilities arising in respect of that <u>Club policy year</u> , <u>the Directors</u> may decide to:			
(a)	transfer any excess or any part thereof to the reserves of the Club in accordance with Rule 23;			
(b)	return any excess or any part thereof to the <u>member</u> s. No return shall be made in respect of any <u>member</u> who has been insured in accordance with <u>Rule 20.9</u> or the insurance of whom ceased by reason of the application of <u>Rule 18.3</u> .			
21.5	Shortfall of funds			
	If at any time after a <u>Club policy year</u> has been closed, it appears to <u>the Directors</u> that the liabilities arising in respect of that <u>Club policy year</u> exceed or are likely to exceed the totality of the premiums and other receipts in respect of such <u>Club policy year</u> (and of all transfers from reserves and provisions made for the credit of or in respect of such <u>Club policy year</u>) <u>the Directors</u> may decide to:			
(a)	transfer funds from the reserves of the Club;			
(b)	levy an advance premium or supplementary premium in respect of any open <u>Club policy year</u> with the intention of applying a part thereof to meet any such deficiency.			
21.6	Amalgamation of policy years <u>The Directors</u> may resolve to amalgamate the accounts of any two or more <u>closed Club policy years</u> into a single <u>closed Club policy year</u> and to pool the amounts standing to the credit of the same. 25.3	Subrogation If any payment is made by <u>the Club</u> to <u>you</u> in respect of <u>you</u> r insurance <u>the Club</u> shall be subrogated to all <u>you</u> r rights of recovery against any person in relation to the relevant matter provided always that <u>the</u> <u>Club</u> shall not exercise any rights of subrogation against any of <u>you</u> r <u>employee</u> s save in cases where there is an allegation of a dishonest, fraudulent, criminal or malicious act or omission by the <u>employee</u> . You have the obligations set out in Pule 14.4 in relation to such claim.
